ABSTRACT

The main motive behind the research was to derive an answer to the discovered problems of the current system of the Zimbabwe Electricity Transmission and Distribution (ZETDC) with regards to the way the fault reports were being carried out and the quality of services offered. The conduction of research through research methodologies such as questionnaires, observations as well as interviews led to problems identification such as being more manual since it does not allow the ZETDC electrical engineers locate the fault easily thus the engineers would manually search for the transformer without any given co-odinates of the transformer location hence the process is timeous leading to long response time to customer problems. Furthermore, the system doesn't help management in calculating overtime and the effectiveness of employees since there is no time recorded in attending to faults, the engineers will sometimes claim more than their overtime leading to incompetence within the organization. However, the main aim of this project is to help the ZETDC electrical engineers to easily locate the transformers for instant response to reported electricity faults. The researcher saw it as key to develop a geographical information system for the ZETDC electrical engineers. The core emphasis on geographical information systems (GIS) is on remote sensing which is an essential tool for the data capturing to subsequently to be incorporated into a GIS and for real time monitoring of environmental conditions for operational management of electricity. The tools that were used in system development includes, PhP, Java script, Xampp, and Micro-media Dreamweaver. In addition the system's major aim was to automate the manual system of ZETDC into a more reliable and less tedious system.

CHAPTER 1: INTRODUCTION

1.1 INTRODUCTION

The main aim of this project is to help the ZETDC electrical engineers to easily locate the transformers for instant response to reported electricity faults. I saw it as key to develop a geographical information system for the ZETDC electrical engineers. The core emphasis on geographical information systems (GIS) is on remote sensing which is an essential tool for the data capturing to subsequently to be incorporated into a GIS and for real time monitoring of environmental conditions for operational management of electricity facilities. Furthermore, the system reports transformer faults and alarms instantly if there is an attempt in transformer vandalism since this has been the major problem to the company since intruders would drain transformer oil thereby lowering maintenance cost of the transformers.

1.2 BACKGROUND OF THE STUDY

After thorough investigations at ZETDC during the researcher's work related learning at ZETDC he noted some problems which were currently being faced by ZETDC as an organization thus there have been a very high response time to customer complains on electricity faults since faults were leading to a decline in total revenue of the company. In addition to that, the customers would go to the nearest ZETDC depot to report the identified faults hence it would take the engineers a lot of time to locate the fault since the transformer co-odinates were not given. Furthermore, ZETDC doesn't have a facility on which customers would report faults from wherever they are. The researcher would do periodic checks on how the customers were served. In addition the researcher saw that ZETDC did not have their transformer locations on the map.

1.2.1 BACKGROUND OF ZETDC

Following the passing of two Acts by the Parliament of Zimbabwe, the Electricity Act (Chapter 13:19) and the Rural Electrification Fund Act (Chapter 13:20) comprehensive reforms have since been experienced in the electricity industry. The Electricity Act also ushered in the formation of four successor companies, the Zimbabwe Power Company (ZPC), Zimbabwe Electricity

Transmission and Distribution Company (ZETDC), ZESA Enterprises and Powertel Communications. In line with the approved structure, ZETDC is the distribution and retail of electricity to the final end user and meeting the challenges of balancing supply and demand, transmission of electricity from existing and new domestic generation plants and electricity trading (imports/exports)

1.2.2 ORGANISATIONAL STRUCTURE

Organisational structure is a structure which depicts the lines of authority, accountability and who can directly delegate to who as well as the chain of communication (Baligh, 2006). Furthermore, Robbins, judge and Millet (2010) added that organisational structure strongly influence on how things get done within the organisation thus the behaviour and attitude of the organisation.



1.2.3 Vision

Vision is an ambitious representation that shows what an organisation wishes to accomplish (Blai, S, 2011). It aids as a crystal clear guide to decide on future and current alternative courses of actions. Vision for ZETDC is to reference point of incredibleness in the procurement of financial administrations and assistance of exchange and travel.

1.2.4 Mission statement

It is a statement that defines the scope of an organisation and purpose, includes customer needs, profit orientation and also community responsibilities (Shim, Siegel and Levine, 1998). The mission statement for ZETDC is to advance financial improvement through effective income era and exchange help. This is accomplished by developing skillful and propelled staff, using ecologically feasible procedures, and engaging with the worldwide group in a socially dependable manner.

1.3 PROBLEM DEFINITION

This is the first phase of the system design and development, it comprises of the documentation of the challenges and approaches put in place for the enhancement of the system (Davis and Yen 1994). However, the geographical information system is a professional system to be established for ZETDC. The current system tend to be more manual since it doesn't allow the ZETDC electrical engineers locate the fault easily thus the engineers would manually search for the transformer without any given co-odinates of the transformer location hence the process is timeous leading to long response time to customer problems. The system doesn't help management in calculating overtime and the effectiveness of employees since there is no time recorded in attending to faults, the engineers will sometimes claim more than their overtime leading to incompetence within the organization. Furthermore the system does not locate ZETDC transformers making it very difficult to resolve faults in time.

1.4 AIM

An aim is a goal which is intended to be achieved and the goal or aim should be attainable. The main aim of this project is to help the ZETDC electrical engineers easily locate the transformers for instant response to reported electricity faults

1.5 OBJECTIVES

System objectives are realistic goals or aims which a specific organisation wishes to attain within a given period (Wasson, 2005). In this regard the research objectives should allow development of the geographical information systems that would.

- Report transformer faults and stores records for future references
- Gives geographical co-odinates of the transformer
- Record time taken to attend to faults helping in coming up with over payments
- Provide a chat platform for customers to report faults.

1.6 INSTRUMENT AND METHODS

Instruments are programming devices which are utilized for the advancement of the framework and the compelling utilization of the accompanying apparatuses will bring about the accomplishment of the proposed framework objectives.

Interviews are formal meetings mostly individually, particularly one masterminded the evaluation of the capabilities of a candidate (Kothari, 2009). Meetings can be attempted with assortment of information sources (administrator to clients), and through option media, for example, by phone or in person.

A questionnaire is an examination instrument comprising of open or closed questions to which the responded should answer to achieve the end goal of social occasion (Fielding, 2006). These are generally used to cover questions on a large number of people.

Observations often require the observer to go to the field to carry out a research based on the actions of the one being observed without notifying him or her (Fielding, 2006). Observations are often more effective when several observations are carried per a given research and if the on to be observed is not aware that he or she is under investigation.

1.7 JUSTIFICATION AND RATIONALE

The development of the geographical information system for ZETDC will be of great essence since it addresses the problems that ZETDC is currently facing, thus, for example, long response time to electricity faults. Moreso, the geographical information system comes with remote sensing which is viewed as an essential tool for the capture of data subsequently to be incorporated into a GIS and for real time monitoring of environmental conditions for operational management of electricity facilities. The system will help management in calculating overtime and the effectiveness of employees since there is time recorded in attending to faults since the engineers will sometimes claim more than their overtime leading to incompetence within the organization

1.8 CONCLUSION

To sum up, the introduction phase enlightens the problems that are currently faced by the organisation and as well as the objectives to overcome these problems. This phase is the initial stage which acts as the foundation of the system development and its successful completion allows proceeding to the planning phase.

CHAPTER TWO: PLANNING PHASE

2.1 INTRODUCTION

As alluded in the preceding chapter, the planning phase is critical in the success of the ZETDC GIS and it basically consists of the feasibility study of the project which will help the management to assess the viability of the project to be undertaken thus whether the project is feasible or not. Therefore the feasibility study helps in coming up with a decision focusing on the economic, operational and technical feasibility. This phase is concerned about the risk involved and their countermeasures in the proposed project and the business value of the proposed system which will be briefly described earlier in this chapter. A scheduled work plan is presented on the Gantt chart where the time will be presented against the activities.

2.2 REASONS FOR BUILDING THE SYSTEM

ZETDC is a nationwide business therefore the need for quick response to faults is needed so as to ensure business effectiveness. The GIS system will enable the electrical engineers to:

- Report transformer faults and stores records for future references
- Locate the transformers by their geographical co-odinates.
- Record time taken to attend to faults helping in coming up with over payments
- Help in increasing organisation competitiveness.
- Reduce customer complains therefore increasing customer trust in the business.

2.3 BUSINESS VALUE

Business value includes the consolidation of a range of values that selects the interests and successfulness of the organisation in the long run through the use of information systems as supported by (Sward, 2006). This chapter gives an overview of the business value of the proposed system and the main motive behind the development of the GIS for ZETDC. The proposed system is designed to address all the identified problems in the preceding chapter which includes failure of the current system to locate faults to mention but a few. Business value does not only cover the economic value thus it can be expanded to client value, managerial value, societal value as well as the security value. Business value is usually not in monetary value thus there is no price attached to the benefit. The GIS will be of paramount importance to ZETDC since it brings the following business values to the organisation.

Client value – this shows the value or benefit to the clients of ZETDC. Client value is attained since the proposed system is more effective thus it speeds up the response time to the electrical faults by giving the coordinates of the transformer faults.

Societal value – the system is of paramount importance to the society since it reduces theft cases of transformer oil, leading to minimal load shedding to the community resulting in a lower cost per unit of electricity to the society thereby enhancing the relations with society hence good will.

Managerial value – managerial value is realised in the proposed system when managers can easily come up with overtime payments for the employees as their actual working time on the site of faults is captured in the system therefore helping managers to come up with accurate payments.

2.4 FEASIBILITY STUDY

Feasibility study is a yardstick measure used for examination of the proficiency of accomplishing the project successfully, bearing in mind a rational monetary budget and diverse variables as supported by (Michele 2008). Furthermore, feasibility study allows project managers to assess the possible outcomes thus positives and negatives before pouring enormous amount of cash and resources to the project. Feasibility study answers the question: Is the proposed system viable given the apparent time and resource constraint? However, for the project to be viable enough the projected benefits should outweigh both the development and initial setup costs. The proposed GIS system will replace the current manual system which makes electrical engineer's work terrible hence the economic, technical and operational factors should be analysed to come up with a decision on whether to partake or not on the development of the proposed system.

2.3.1 TECHNICAL FEASIBILITY

Technical feasibility is the assessment of the compatibility of the proposed system with the currently existing technologies (Dawn 2002). This assessment heavily relies on the system requirements summary, to foresee if the organization is proficient enough to undertake the project to the end. A feasibility study is an essential tool for problem solving, future planning as well as decision making. Technical feasibility should answer the following questions?

- Is the proposed idea feasible within the limitations of the technology at hand?
- Is there adequate hardware and software infrastructure?
- Is the technical expertise available?
- Does the system address the current problem?

After the above questions have been favourably addressed it has been acknowledged that the development of the proposed system should be continued without interfering with the existing system since the technical benefits outweighs the drawbacks. An overview of the technical feasibility is depicted in the tables below. Table 2.1 indicates the hardware prerequisite for the system to function as expected.

Technical expertise

This helps on assessing whether the available workforce is able to tackle the challenge of the proposed GIS system or not. However, the decision is made based on the assessment thus whether the existing personal will be trained to do the proposed project or the company should hire new employees to carry out the task on behalf of the organisation. ZETDC has a well-grounded IT infrastructure which comprises of programmers, systems analysts, database administrators as well as technicians. In conclusion, ZETDC is willing to commit the resources to the project and has the required workforce and experience to tackle the challenge of developing the proposed system.

2.3.2 ECONOMIC FEASIBILITY

This is a technique used for evaluating the effectiveness of the proposed project through an assessment of economic benefits to costs. This economic analysis incorporates the economic benefits and costs so as to determine on decision whether the project continues or it will be terminated thus the project will only continue when the economic benefits outweighs the costs. (Brown, 2008) supported the view that if the general advantages exceeds the costs then the economic feasibility will be considered to be positive. To carry out a successful economic feasibility, there are several decision making techniques that can be used such as the payback period, return on investment and the interest rate of return to mention but a few.

Costs

In systems development, costs can be classified into development, operational as well as set up costs. These costs can be regarded as monetary valuation of action, time, forgone alternatives, materials and assets for the development of the proposed GIS system for ZETDC. However, the ZETDC finance department considered the project to be of paramount importance to the organisation, so it decided to pour some funds for the project when required from the commencement of the project.

Development cost

These are cost associated with system development and are usually incurred during development phase and these include team remuneration and training costs, additional material costs to mention but a few (Brown, 2008).

Benefits

These are the proceeds brought about from the utilization of the system that should help the organisation in achieving its goals (Kotler, 2012) and the proposed system benefits can be classified in tangible and intangible benefits.

Intangible benefits

These are benefits that are elusive thus one cannot touch or feel and they cannot be easily assigned a monetary value (Cohan, 2005). Non tangible benefits include love, companionship, establishment and goodwill. Non tangible benefits include:

- Increased organisation good will.
- Enrichment of customer satisfaction.
- Increased employee morale and job security.
- Data security and integrity.
- Time saving.

Tangible benefits

These are benefits that accrue to the organization after utilising the proposed system and a monetary value can be easily assigned to the benefits (Cohan, 2005), for example increased yield or reduced cost.

Cost benefit analysis

Cost benefit analysis is a financial analysis tool that is mainly used by project managers that helps them to come up with projects that have a great benefit as compared to costs. Cost and benefit analysis serves as a comparative tool for the organisation by assessing the proposed system expected costs to benefits (Bently ,2007).

The cost and benefit analysis done by project managers for ZETDC GIS system depicts that the proposed system was of paramount importance to ZETDC since the company was incurring a loss of \$1000 hence the introduction of GIS lead to a profit of \$2000 in 2018.

Return on Investment (R.O.I)

R.O.I is a performance measure that is used to give an assessment of the proposed system or project and is usually determined by the difference between the total costs and proceeds of the project (Kalvar, 2003).

R.O.I is calculated as follows:

(Average annual profits/Total investment) *100

However, R.O.I was used by ZETDC project managers and the results were as follows

Average annual profits = \$2800 + \$3700 + \$4500 = \$12000

\$12000\3 = \$4000

Total investments = \$1000 + \$2000 + \$1200 = \$4200

R.O.I = (\$4000/\$4200)*100 = **95.2%**

Decision:

The project is favourable since the return on investment (R.O.I) is greater than 50% hence the system is of value addition to ZETDC.

Payback Period

Payback period is an investment appraisal technique which takes into account the amount of time taken by a project to cover its initial capital (Schwalbe, 2006). The technique is based on the assumption that projects with a shorter payback period should be considered first given that it does not exceed its payback hurdle period. This technique is very useful when the financial resources are limited.

The payback period for the ZETDC GIS system is calculated as follows:

1year + (2500/4500)*12 = 6.6 moths

Payback period = 1year 7 months

The GIS project is considered to be financially viable since it has a shorter payback of 1 year 7 months.

2.3.3 SOCIAL FEASIBILITY

This phase concentrates on the well-being of the proposed system to its society where it will be presented to the users (Brown, 2008). However, the proposed system should be of social benefit for it to be accepted by the stakeholders. Stakeholders include everyone that is directly affected or have an interest in the business activities and these include the shareholders, government, employees, customers and the community at large. Taking social feasibility into account the ZETDC development team made use of prototypes where the users were involved at each stage of production aiming to meet the stakeholder requirements hence reducing chances of product failure. The development of the proposed GIS system for ZETDC has been considered as socially feasible since it reduced response time to electricity faults and reducing chances of electricity oil theft thereby benefiting both the customers and the employees. However, the introduction of the system would pose a challenge to other employees since it weakens their job security.

2.3.4 OPERATION FEASIBILITY

This phase indicates how the proposed system fulfils the stated requirements in the requirement analysis phase and measures how the proposed system addresses any given challenge (Fracheti, 2011). Operational feasibility is keen to see how the proposed system blends with the current environment of the business with an aim to improve the current business systems. It focuses on the questions such as are the employees viewing the change as inevitable, are the top management fascinated with the proposed system, are the customers satisfied with the system. However, ZETDC's top management showed their commitment to the project by the provision of the required enormous sum of \$6000 for the project to commence. The system has been easily accepted since it made work ease and was able to tackle the given challenges.

2.4 RISK ANALYSIS

Risk analysis is a technique used to highlight potential threats that may arise due to the use of the proposed system Kotler (2012). Risk analysis is a technique that requires a lot of time to identify the factors that may jeopardize the on-going of the project. It also identifies the level of risk involved and the possible measures to be taken to counter the identified challenges. Generally

there are two types of risk analysis that are qualitative and quantitative and a table below shows a quantitative risk analysis.

2.4.1 TECHNICAL RISK

Technical risk is associated with the users, and these can be viewed as technical challenges faced by the users in trying to use the system hence ZETDC overcame these challenges by training its system users thus the employees on how the GIS works. Furthermore, user manuals have been created and distributed all over the organisation.

2.4.2 TIME RISK

The time risk is the risk that is associated with the failure of meeting the deadlines of the project. The time risk however helped the project managers in identifying critical activities thus activities that must not be delayed such as system development. However a work plan have been drafted for the whole project which states what is supposed to be done at a given time. A Gant chart was also developed showing the amount of time taken by each activity.

2.4.3 ECONOMIC RISK

This is a risk that is beyond the organisation's control such as inflation, balance of payment (BOP) and the exchange rate. With all these in consideration, it has been viewed that the project would be successful given the current economic state of Zimbabwe. Inflation rates seemed to be stable as well as the exchange rates hence purchasing of software and hardware resources within or outside would not be a challenge. Cash shortages in the economy has been viewed as the major destruction to the ease going of the project, however, alternatives such as RTGs or swipe cold be used to overcome the challenge.

2.5 STAKEHOLDER ANALYSIS

Stakeholder is someone that is directly affected or someone that is interested in the activities of the business for instance the GIS project (Bently, 2007). Generally there different types of stakeholders which include: employees, government, community customers, shareholders to mention but a few.

Customers

Customers are considered to be the key stakeholders in the organisation since their responses will ensure continuity of the business. The newly developed GIS system has been of paramount importance to customers since it ensures quick response to electricity faults and it comes with a chat platform where they can communicate their queries unlike the old suggestion boxes which was not effective.

Employees


Employees viewed the system as of great importance since its emphasis was to ease the work for employees by easily locating faults hence reducing disputes with the management as well as with the customers. The system will also facilitate accurate overtime payments for the employees since they will logon start and end time.

Shareholders

These are people who have invested stake in the business and in the case of ZETDC there are no direct shareholders since it's a state owned company therefore the shareholders are the board members and the top executives. The shareholders were pleased with the new system since it reduces loss of revenue due to high incompetence of the organisation.

2.6 PROJECT PLAN

A project plan highlights a sequence of activities showing the stages that will be encountered to the accomplishment of the project as supported by the project management board of knowledge (PMBK). A good project plan should have well defined stages that should be met one after the other. On the GIS system project the project team decided to use the waterfall model which is also known as the traditional model. The waterfall model has well defined stages and is easy to understand and the system requirements are stated before venturing into the project.

2.7 Conclusion

Conclusively, since all the stages under the planning phase are gone through and the project appears to be feasible enough to be put in practice so the researcher will have to proceed to the next phase which is the (analysis phase) in chapter 3.

Chapter 3: Analysis Phase

3.1 Introduction

This phase is of great essence to the success of the project since it gives a greater highlighting and an overall description of the entire current system that is being utilized by the organization. The prime goal of this phase is not on the newly proposed system but to provide a deeper analysis and understanding of the current system. In addition to that, for a detailed analysis to be done different gathering techniques have been used to come up with effective information about the current system, in order to pave way for a successful completion of the project. An evaluation of the current system will be made based on the benefits and limitations of the current system. Furthermore, a dataflow diagram, a context diagram and a process modeling are drafted in this chapter giving an insight of how the current system operates.

3.2 Information Gathering Methodologies

Information gathering methodologies are fact finding techniques where the decision will be based on the collective opinions and reactions of the users (Yeates, 2014). To come up with a sound decision, different data gathering techniques have been used which include: interviews, questionnaires, observation to mention but a few. The researcher managed to gather information in Harare at the ZETDC head office using different data gathering techniques as follows:

3.2.1 Questionnaires

A questionnaire is a rule book that has governed questions to be attended to by the user by either filling in the blank spaces or by ticking the required boxes (Bently, 2007). However, the researcher managed to generate and set questions to be presented to both the employees and the clients. The questions were designed such that there will be open-ended questions that prompts the user to give answers based on their point of view and usually provide blank spaces to fill in, for instance, how does the current system operate? However, the researcher also made use of closed-ended questionnaires that sticks to the "yes or no" answer and are usually filled in by a tick in a blank box. Both the closed-ended and open-ended questions have been drafted by the researcher and distributed on a clean white sheet at a ZESA press conference targeting the top executives, employees, system developers as well as the customers. Furthermore, for the researcher questionnaires appeared to be advantageous than other methods such as interviews and observations as it saves time and is very cost effective since there are less inputs required.

Moreso, questionnaires also appeared to be one method that can only be used to address a large multitude of people at once such as at an AGM without interference. Alternatively, using questionnaires have been a great challenge since the rate of reaction as occupied and busy individuals may be very poor to the given questionnaires. Furthermore, closed-ended questions do not permit individuals to fully answer the given questions.

3.2.2 Interviews

These are fact finding techniques where formal meetings are conducted individually and the communication is verbal two and way between the interviewee and the interviewer (Willson, 2013). The researcher conducted interviews in several ways which include the use of technologies such as video conferencing, cellphones or in person. The researcher in this case the interviewer arranged the interview date and time with the interviewee in this case the employee, customer. The researcher, however, for proximity he conducted the interviews in person so that he can pick the non-verbal cues and emotions of the interviewee. ZETDC is a very big organization, so that interviewing everyone at the organization would be very tiresome and almost impossible so interviews were done at random targeting the employees that are directly affected with the current system that are the electricity engineers. However, other employees have also been interviewed including the customer in order to get diverse views of the system from different point of view. With the use of interviews the researcher would give the interviewer room to change to meet the requirements of the interviewee. Furthermore, the researcher would pick raised emotions and use of non-verbal cues added very important information that cannot be raised by the interviewees. Unlike other research methods such as observation and questionnaires interviews helped in building relations between the interviewer and the interviewee. The researcher also experienced some misconceptions that rose and as a result it was quickly resolved with the use of interviews. However, interviews overall planning and conduction have been very tedious and time consuming for the researcher. Furthermore, the researcher discovered that the outcome of the interviews heavily depends on the effectiveness of the interviewer thus if the interview is not well structured the results may be misleading. In addition, the researcher figured out that interviews have been a more costly method in contrast to other methodologies.

3.2.3 Observations

Observation requires the researcher in this case the observer to monitor the reactions of the users towards the current system that is being used. The researcher observed at different ZETDC depots not making it so clear for the observed to suspect in any way suspect that they are being observed. However, the researcher managed to carry out his observation of some engineers deployed from the heard office in Harare to search for a fault in Mabvuku and other several cases. The researcher managed to carry out the observation without the employees suspecting that they were being observed. Thus the researcher saw that the employees have been reluctant since they were aiming to maximize on their overtime payments. Observation helps the researcher to draw the actual picture than to base on the speculations done on other methodologies. The researcher managed to carry out several observation so as to get a bigger picture thus the researcher also observed the fault that he reported to ZETDC himself. Furthermore the ZETDC fault recovery wasn't good enough, however, in contrast to other methodologies the researcher viewed observation as less costly. On the other hand, without full knowledge of whether the employees were aware that they were being observed or not the researcher saw observation as misleading in some way. Furthermore, the researcher faced some challenges while trying to observe the engineers try to rectify a problem since some of the reported faults may take days working on the fault. In addition to that the researcher realized that he can forgo some quality features such as instructions given by the management as well as full knowledge of electricity and the measures to be taken to recover the fault.

3.3 Analysis of the Current System

According to Bently (2007) it is an examination of the existing system that mainly focuses on the negatives of the system so as to conceal the highlighted weaknesses when developing the new system. However, the assessment of the current system should be based on the information that has been collected from the different data gathering techniques. Furthermore, the problem definition highlighted earlier on that the existing system at ZETDC tends to be tedious since it is more manual.

3.3.1 Current System Description

The current system operates as follows:

The customers will have to visit any ZETDC depot to report the fault. After fault reports have been made, the engineers will have to manually search for the fault in the specified location. Customers in this scenario will only work on faith as there is no feedback given to them until the fault is recovered. This however will lead to constant checks and reports being made by several customers concerning the fault.

Inputs

For fault reports to be made it is mandate that the necessary inputs are highlighted for the customers to know what they are required to provide. Inputs can be described as unprocessed information that is positioned in a system with an aim that it can get a yield.

ZETDC clients should provide the following inputs when reporting a fault.

- ✤ Name and Surname
- ✤ National ID number
- Physical address/ location
- ✤ Date of fault occurrence

Processes

A process is an illustration that highlights actions to be carried out in a system. To be more precisely, a process is an element that varies and requires proper planning of entities in which processors are selected (Matha, 2000). The process of the current system is highlighted below.

- ✤ The complainant or client visits any ZETDC depot.
- ✤ The client joins the queue.
- ✤ The client issues the required inputs.
- ✤ The client reports the fault.
- ✤ The client waits for fault confirmation.

Output

Output provides answers to the conveyed inputs. The inputs and the processes result in the highlighted outputs (Sommerville, 2004).

✤ Fault report have been produced.

✤ A fault has been recovered.

3.4 Process Analysis

This phase can be described as a sequence of activities or actions heading to reach a specified target. This phase can be further classified as short description for the user that highlights the procedures of fault reporting by the customers.





Fig 3.1 Process Analysis

Context Diagram





3.6 Strengths and Weaknesses of the Current System

Like any other system the current ZETDC fault recovery system has its own strength and weaknesses to be shown below.

Strength of the Current System

- The current system allows use of emotions since there is direct contact of the client and their service providers hence resulting in quick attendance to the fault.
- Constant contact of the client and the service providers may lead to increased relations between them.

Weaknesses of the Current System

- The current system is very costly to clients since they will have to commute to reach a ZETDC depot.
- The current system is time consuming for both the clients and electrical engineers since it does not help them in fault recovery.
- Data capturing is done manually so there are hire chances of data loss.

3.7 Evaluation of Alternatives

Before proceeding with the project, the project team had to consider other available alternatives to develop the newly proposed system which are outsourcing, in-house development and lastly perfecting the existing system. To be more precisely, it is of great essence for the project managers to select the best alternative making use of the cost and benefit analysis.

3.7.1 Outsourcing

Outsourcing occurs when a company has no intentions to develop the system in-house but it would get the system from a reputable development company for a fee Biggs 2000) et al. When an organisation chooses outsourcing it will be of great importance for it to train its employees on the system to be implemented, so that they will familiarize and get to know the new system requirements. However, outsourcing has its pros and cons that are discussed below.

Advantages of Outsourcing

- It saves time and therefore outsourcing can accord more time for the company to focus on its core system rather than on the system itself.
- Outsourcing reduces risk of system exploitation since it is developed by more skilled and equipped labor and therefore reduced bugs.

Apart from that, outsourcing is cost effective since there are no administration, operation and recruitment cost associated with the need for an IT infrastructure for an in-house development of the system.

Disadvantages of Outsourcing

- There is a very high risk that the system developers may leave backdoors so that they can have unlawful access of the company's confidential information.
- Outsourcing is also associated with recurring cost such as system licenses yearly which may end up being costly than building the system in-house.
- The trained individual may fail to grasp some concept of the system hence may lead to additional cost

3.7.2 In-house System Development

This way of system development requires a set-up of an IT infrastructure and the recruitment of skilled labor since the system development occurs within the organisation usually for own use, using the accessible resouces (Kenneth and Kendell, 2011). The pros and cons of in-house development are highlighted below.

Merits of In-house System Development

- The method creates a bond between the system users and the system developers through constant interactions.
- In-house development comes with more convenience since everything is done in total control by the organisation, helping in coming up with flexible schedules.
- It will be more confidential since there will be no third part having access to the developed system.

Demerits of In-house System Development

- Setting up an IT infrastructure will be costly adding overhead costs.
- The developed system might not have a resale price since the system may be designed to suit only the specific organizational needs.
- In-house development might not be the suitable method when the system is required in short period of time since it requires a short time.

3.7.3 Improvement of the Current System

Improvement of the system is done internally without outside help to carter for system worrying issues particularly affecting system functionality (Kiddiq, 2014). This method requires alterations to be done on the existing system so as to make it more proficient and practical for instance the manual ZETDC fault reporting system. This system development method has its own costs and benefit to be shown below:-

Benefits of Improvement of the Current System

- Improvement of the current system does not disturb the normal operation of the business since time can be devoted for system improvement.
- It is less costly as compared to other methods since little resources and additional training is required.

Costs of Improvement of the Current System

- ♦ A change from manual to complete automation of the current system may be very timeous
- If the project to be improved is too big it may disrupt other business activities
- Some of the problems can only be identified but will be very challenging to address and therefore no alterations will be done.

In coming up with the best alternative method the project team had to make use of the cost and benefit analysis for evaluation. With the aid of the of the cost and benefit analysis and other evaluation techniques the project team opted for the in-house development as it had a higher initial cost but they were once of costs and not recurring costs and no special training required as compared to other methods and the project will come with higher levels of privacy since some organizational information may be very sensitive.

3.8 Requirements Analysis

This phase simplifies and highlights the requirements of the system underway. Thus the phase has two categories that are subdivided into the functional and non-functional requirements that are to be explained below:-

3.8.1 Functional Requirements

This phase focuses mainly on clients therefore aiming on enhancing clarity on the client needs and how those needs will be addressed and it stretches up to the expected standard of the system performance (paradkar, 2017). To be more precisely, the functional requirement phase focuses on the feasibility of the proposed system and concentrating on the usefulness thus whether the system will be in line with the business objectives or not (Stephanidis, 2003). However the is supposed to help both the clients and the engineers in electricity fault recovery thus the customer will log a query inform of a chat from wherever they are and the system will however help the engineers with giving the location co-odinates of the fault. The functionality of the system is highlighted below:-

- The proposed system should consist of a group chat platform that enables the users to report the faults online by providing their contact details thus their name, surname, physical address and location.
- The customer should get the ZETDC fault recovery application online so that they can overcome distance barriers.
- Clients should get the feedback on their requests concerning the date the recovery is supposed to be done and be updated when the fault has been recovered.
- ✤ Furthermore, the engineers should be updated by the system about the fault.
- ✤ The system should give the location co-odinates of the transformer fault.

3.8.2 Non Functional Requirements

These are the principles that are used on the analysis of the system (Nikkola, 2011). During system development there will be expectations to experience challenges and these are the non-practical conditions of the proposed system. There is an inverse relationship between the non-functional requirements of the current system and the functional requirements of the proposed system (Sommerville, 2004). The non-functional requirements are highlighted below-:

- ✤ The proposed system should have data integrity and security thereby avoiding data loss.
- The system should have data security thus enabling data backups.
- It should be available when needed to all the clients
- The system should make work more easier and be time saving
- ✤ It should have a good graphical user interface and be user friendly
- It should also enhance security so that those people without direct access to the system cannot manipulate or change anything on it.

3.9 Conclusion

The researcher in this chapter used different data gathering techniques in which the evaluations were made of the best method. Furthermore, overall analysis of the current system was done on analysis phase showing the pros and cons of the existing system. However, the limitations of the existing system overweigh the benefits leading to the proposal of a new system by the project developers. After this phase the developers will proceed to the design phase.

CHAPTER 4: DESIGN PHASE

4.1 Introduction

The design phase concentrates on the generation, configuration and delivery or deployment of the proposed system (Rana, 2013). This chapter clearly explains how the system to be developed will look like. The functionality of the proposed system will also be well outlined in this chapter, so generally the design phase emphasizes on the architectural design, physical design, interface design, database and file specification and the program design.


4.2 System Design

The design illustrates how the proposed system operates, in terms of hardware, software, interfaces, network infrastructure, forms, database and files; this is fashioned through the use of set of guidelines and techniques (Stasinopoulos, 2013). Validity of the proposed system is considered a good design when the following objectives are met:

- Flexibility the design should allow incorporation of future requirements without too much toil or strain.
- Maintainability a good design should be easy to maintain.
- Portability a good design should have the capability of being transferred from one machine environment to another, with the least amount of converting effort.
- Easy to use a good design should be user friendly, that is easy to learn and understand, and also straightforward to operate.
- Reliability a good design should secure against human error, that is production of correct results and being trustworthy, and should also be available when needed by the user
- Security a good design should also secure the confidentiality of data.

4.2.1 Context Diagram

Context diagram defines the margin between the system and the systems environment, highlighting the main actors (entities) that interact with the system (Kenneth and Kendell, 2011). Context diagram is made of the system of interest at the middle, enclosed by the entities who interact with the system. The context diagram of the new system is as:

4.2.2 Dataflow Diagram (DFD)

Dataflow diagram is a more advanced context diagram that clarify the relationship between and among several components in the system. Dataflow diagram is a vital method which is used in modelling of the system (Butt, 1994). Construction of a DFD for the new system was done to ensure that all the essential modules were defined. The DFD illustrates the movement of data thereby making it easier to comprehend the movement of data. The following fig indicates the framework's DFD:




Figure 4.1 Context diagram

4.3 Architecture Design

The architecture design is the formal background in which the system components interact thus the software, hardware as well as network setup of the system to be developed (Fisher, 2008). The architecture design also consists of a brief description of how the system will behave, the system dataflows and their communication or relationships. This phase gives a highlight of the proposed system features into a logical and functioning system in line with the stated system objectives. The diagram below depicts architecture design of the GIS for ZETDC.




Figure 4.3 Architectural Design.

4.3.1 The Client Server Approach

The approach comprises of an application that allows the combination of the clients and the server on the computer system and is done through the process whereby clients request resources from the sever (Kenneth and Kendell, 2011). The client server model best works when both the server and the client have different tasks that they regularly perform, for example, on the geographical information systems for ZETDC the sever side saves the system from failure and notifies the user that a certain tasks cannot be performed while the client side will only ensure that fault details entered by the client is valid thus it saves time for the server by handling invalid data. The structure of the proposed geographical information system is a web-enabled system which also makes use of web-servers. This approach has been chosen since it comes up with the user friendly interface for the clients and as well making the source code invisible for its clients.




Figure 4.4 client server approach

4.4 Physical Design

The physical design is a way of altering the given model into a real tangible system that shows the way of components arrangement thus the system users, hardware as well as software to be developed (Wasson, 2015). The physical design depicts the system components integration thus how the components communicate within the new system.




Figure 4.5 Physical Design

4.5 Database Design

This is a method of producing a clearer and meaningful data model (Dennis and Roberta, 2012). Generally there are six major steps in database design which include requirement analysis, conceptual database design, logical database design, schema refinement, physical database design and application and security design. Database design comprises of information arrangement which is entirely explained in the database schemas. However, the development team took into account the six steps previously stated.

- Requirement analysis this involves consultation of the system potential users to get the required information such as data to be stored and the desired operations and requirements.
- Conceptual database design it involves the construct of a best explanation of data and constraints.
- Logical database design this is the conversion of the conceptual model to the relational model.

Schema refinement – involves the processes of problem identification and trying to address the identified problems.

4.5.1 Database Design Architecture

It is an exercise that outlines the governing procedures, steps and conditions relating to storing and inserting the data in database and it also determines the people who can have access to the given database between the various users (Meyer, 2007). The research team made use of the ANSI-SPARC model which will be highlighted below with its three levels.

The Three Level Architecture: ANSI-SPARC

The architecture consists of three levels which include the external level, conceptual level as well as the internal level. The major aim of the model is to hide the physical storage details from the system users (Coronel, 2008).

External level

This level represents the user's view of the database and may present the same data differently for example clients may view the date as (day/month/year) while employees may view it in other format (year/month/day) and it describes a portion of database that has a significance to the targeted user (Sommerville, 2004). The external level is of great importance since it includes derived or calculated data for the system users who include the clients, employees and managers.


Conceptual level

This level is also known as the community's view of the database and it defines the data stored in the database as well as the relation among the given data. Thus the conceptual level signifies all the entities, the given attributes as well as their relationships, it also shows the data constraints and provides the data integrity and data security information (Sommerville, 2004).

Internal level

The internal level defines how data is to be stored in the database by the file organization and data structures. This level is more concerned about storage space allocation and tables, defining the format the records will use after being stored, data location, as well as the techniques of data

compression and encryption. After the internal level is the physical level controlled by the operating system (Sommerville, 2004).




Fig 4.5 Entity Relationship Diagram




4.7.1Package diagram






Figure 4.10 Sequence diagram.





Figure 4.11 Interface Design


4.8.1 Menu Design

This design is available to every user as one should be able to change their password at any given time because of security reasons to avoid unauthorized individuals to make use of one's password.




Fig 4.14 Change Password Platform

4.9 Security Design

Security design is an approach to software and hardware development that that intends to build systems as free of vulnerabilities and impervious to attack as possible through such measures as continuous testing, authentication safeguards and adherence to best programming practices (Gouin, 2007). The system must be secure from outside clients as this reduces the danger of alteration of data by unauthorized clients. Data can be secured by use of programming controls. In the system the database administrator has actualized programming controls and this integrates the use of passwords whereby level of authorizations and parts are set characterizing whether the user is as super user with super rights. The security feature given by this system has two levels. The principle level is section into the system itself that is, having admittance to where the system

is. The segmentation router and hub will cater for this. Access records are arranged on this router to deny access from terminals.

The other level of security is having authentication on the system itself. An unauthorized user may have figured out how to bypass the primary level by changing their IP address to match any of the ones permitted access. The second level is there to facilitate that it is secure just in case one will have been able to pass the first level. The system gives a log-in feature where secret key entered is checked.

4.9.1 Physical security

Physical security is the safeguarding of personnel, hardware, networks, programs and information from physical circumstances and events that could cause serious damage or losses to an enterprise, institution or agency (Layton, 2016). This involves protection from natural disasters, fire, theft, burglary terrorism and vandalism. Physical security is often overlooked in favor of more dramatic and technical issues such as hacking, Trojans, viruses and spyware. Therefore, physical security breaches can be undertaken with little or no technical knowledge on the end of an attacker. In addition, natural disasters and accidents are part of everyday life and they are inevitable in the long term.

Physical security has three main components. Firstly, complications can be placed in the way of potential attackers and sites can be protected against accidents and environmental disasters. Such actions can include multiple locks, walls, fencing, fireproof safes and water sprinklers. Secondly, surveillance and notification systems can be used, such as heat sensors, smoke detectors, intrusion detectors, cameras and alarms. Thirdly, processes can be implemented to capture attackers and to recover quickly from accidents, fires or natural disasters.

4.9.2 Network Security

Network security is the process of taking software and physical precautionary measures to protect the underlying networking infrastructure from unauthorized access, misuse, malfunction, destruction, modification or improper disclosure, thereby creating a secure platform for computers, users and programs to perform their intended critical functions within a secure environment (Poole, 2007). The auditing process of network security requires checking back on implementation measures to determine how well they have aligned with the security policy. Auditing urges continuous improvement by requiring organizations to reflect on the

implementation of their policy on a consistent basis. Organizations are given the opportunity to adjust their policy and enforcement strategy in areas of evolving need.

4.9.3 Operational Security

Operation security refers to a risk management process which enables managers to protect sensitive information to get to unauthorized users (Voelz, 2011). A process of identifying critical information and subsequently analyzing friendly actions attendant to the transformer geographic information system tracking operations and other activities to:

- a) Identify those actions that can be observed by adversary intelligence systems.
- b) Determine indicators that hostile intelligence systems might obtain that could be interpreted or pieced together to derive critical information in time to be useful to adversaries.

Select and execute measures that eliminate or reduce to an acceptable level the vulnerabilities of friendly actions to adversary exploitation

4.10 Conclusion

CHAPTER 5: IMPLEMENTATION PHASE

5.1 Introduction


Implementation phase concentrate on system coding, testing, installation and maintenance of the developed system(Moreira, 2004). Testing is undertaken with the intention of confirming if the new system is performing as expected (objectives are met and problems solved), through the process of validation and verification. The changeover strategies on installation are well described in this chapter as well as different maintenance activities, and lastly the recommendations are outlined and evaluation of objectives to review the success of the new system is undertaken.

5.2 Coding

Pseudo code phase involves the procedures enveloping the changing over of the proposed system rationale into particular directions executable by the PC (Petrie, 2014). Pseudo coding is otherwise called a programming stage, when the software engineer changes over the determinations of a system into PC justifiable language (Gupta, 2008). The programmer in this scenario will use PHP and HTML for the coding phase. Moreso, pseudo code shows how the proposed system was customized, which includes the each stage's project stream, builds for circling and the structures utilized by the software engineer as a part of system regulatory.

5.3 Testing

This stage involves the process of identifying the new system failures or faults and takes the possible procedure or measures to come up with a better system before system distribution (Kenneth and Kendell, 2007). Testing works in line with the verification process thus confirming if the new system is operating as anticipated. This process is carried out to expose the unidentified system errors in preceding chapters. However, as for this project the research team used various testing techniques which includes verification and validation, integration, unit testing, black and white box testing and lastly system and acceptance testing. The diagram below will help to give a further explanation about the testing processes.



5.3.1 Unit Testing

Unit testing phase is a technique that focuses on giving more attention or focus to an element and the main objective being confirming whether the individual elements are operating as intended (Stephanidis, 2003). Unit testing comes up with its own main advantage which is making it easier to identify each element error as compared to identifying the whole system errors at once. Thus the system elements were tested individually, for example, the registration and the login element. Furthermore, the research team made use of the verification and validation process. The research team also used the registration element for their unit test which would successfully create a user account if the user enters correct registration credentials for them to login to the system, however, the registration unit test continues by rejecting user access to the system if the registration element is unsuccessful thus they won't be able to login to the system.

5.3.2 Verification and Validation

The validation process aims on building the right system and is attained by the process of calibration which compares whether the developed system is a correct representation of the proposed system whereas, verification process aims on developing the right system concentrating on questions such as is the system developed as intended? And is the system implemented correctly in the computer? (Sommerville, 2004). The diagram below shows the calibration process and validation of system models.




Figure 5.2 Calibration Process




Figure 5.3Verification and Validation

5.3.3 Login Testing

The ZETDC GIS system has been tested to see if it validates properly thus if the user uses a wrong email address and password. Thus if authenticated very well it should deny the user access to the system.

5.3.3 White Box Test

(Sommerville, 2004) the white box test outlines the actual system organization as well as the source code procedures. Thus this method is mainly concerned about the inner features of the new system. The research team used the step by step technique when monitoring the system performance in white box testing and the results were obtained at each phase and every single code segment was validated. This phase gives an in-depth analysis of the interior features of the system thus the system source code.




Fig 5.6 White Box

5.3.4 Black Box Test

The researchers obtained this by testing if the system is operating as they intend and indeed the system met the stated objectives. This, however, guaranteed the research team of data consistence of the system as the system met its requirements.

5.3.5 Integration Test

5.3.5 System Test

5.3.5.2 Beta testing

Beta testing advises clients in instances where the inputs are not valid. Moreso, information acceptance by the system is displayed in beta testing.

5.3.6 Acceptance Test

The usefulness of the system is tried in acknowledgment testing by the clients of the system McWatters, Zimmerman and Morse (2010). Acceptance testing is normally done final in testing and the final users will subsequently complete the test being more worried about the system functionality (Gupta, 2008), so the system was given to the end clients to assess the system usefulness. This testing phase comprises of beta and alpha testing in reliance with the examinations of information. It is revealed that acceptance test gives vital answers to the already obscured mistakes, which were not really perceived in the before tests (Hoffer, 2003).

5.4 Installation

5.4.1 System Changeover

5.4.1.1Direct changeover

This strategy comes up with the following advantages and disadvantages

Advantages of Direct Changeover

- Reduced execution time prompting quick conveyance of the system.
- It is likewise connected with low transformation and working expenses
- A solitary system will be running at a specified time, therefore there will be low linked expenses.
- A short timeframe range for a complete system changeover is needed.

Disadvantages of Direct Changeover

- High levels of risk and very expensive model if the framework comes up short.
- Denial of the new system by end clients.
- Disruption of work on changeover process.

5.4.1.2 Parallel conversion

Parallel change includes a simultaneous utilization of both the old and new system with the goal of seeing if the new system executes as expected (Schwalbe, 2008). Both systems will be preparing and executing the same occupation or assignment. At the point when the usage of the new systems is regarded a win, then the old framework is deserted and the new framework assumes control over the employment completely. This strategy comes up with the following merits and demerits

Merits of parallel conversion

- The penalties of the new system are confirmed.

Demerits of parallel conversion

- It is unreasonable to run two frameworks simultaneously.
- Takes a more time range before a complete change is made.

- There will be an increase in workload

5.4.1.3 Phased conversion

Phased change is the release of another system in stages Hughes et al (2005). On the off chance that one stage is effective then the execution of the following stage starts, this in the end leads to the last stages when the old system will be completely substituted with the new system. These are some of points of interest and detriments of this technique.

Advantages of phased conversion

• The danger is stuck just on a solitary module thus if there should be an occurrence of any issues, just a single range will be influenced. Associated with less expenses in relationship with the immediate transformation.

Disadvantages of phased conversion

- Longer time range is required before a complete transformation is made hence time consuming.
- Associating the new system module with the present system might be unrealistic.

5.4.1.4 Pilot conversion

This phase includes initiating the new system with just a set number of clients, more often than not a solitary division whilst different offices are as yet making utilization of the present system (Pressman 2011). Advantages of pilot conversion

- Associated with a lesser hazard than the immediate conversion strategy.
- Less expensive when evaluated with parallel conversion.

Disadvantages of pilot conversion

- There is the likelihood that the system can execute magnificently on the pilot then comes with failures in organization.
- It is time consuming.

Changeover Decision

The development team preferred to use the phased conversion since it has proved to be less costly than other strategies thereby it is in line with the overall organizational goal which is cost minimization so ZETDC executive agrees over the use of the phased conversion in system implementation(GIS).

5.4.2 User Training

User training is of great importance to ZETDC since it enables familiarization of all the system entities to the new system on the system functionality thus on how the system works and how they will work with the system to avoid dilemmas brought about by the use of new system. Training of users also grant the system users knowledge about the system and security to their job since they will be recognized as part of the organization because of user involvement in the system which will reduce the chances of resistance to the developed system. User training was conducted very well at ZETDC for the new system since the users felt part and parcel of the organization.

5.5 Maintenance

Maintenance is a continuous procedure which is performed on regular basis with the intention to satisfy that the new system executed is working legitimately is as yet fulfilling the necessities details it was worked for (Sommerville, 2004). Formerly the system has been executed; certain redesigns are done on the system programming with the goal of enhancing its execution and making it to conform to the steadily evolving environment. Since client necessities are always showing signs of change, conservation is a continuous procedure. The types of maintenance comprise of adaptive, preventative and corrective.

5.5.1 Corrective Maintenance

5.5.2 Preventive Maintenance

Preventative maintenance is a measure to curb system failures when executing the suggested tasks. This sort of support does not sit tight for blunders to happen but rather it expects mistakes that may happen before they truly happen and a precaution move is made to keep these blunders from happening (Stephanidis, 2003). Commonly, the preventative maintenance is about making upgrades on the system directive and the formats of the interfaces of the system.

5.5.3 Adaptive Maintenance

This technique helps the developed system to comply with the changes in the operating environment (Sommerville, 2004). Adaptive maintenance occurs when the system can adapt to changed system hardware and software, for example, if the system can operate on a hp 64 bit 8 gig ram with a windows software and can as well perform the same functions on a dell 32 bit 2 gig ram using Linux software. In case of the developed system for ZETDC it adapts to the changes in the operating environment.

5.5.4 System Backup

System backup is of paramount importance since in cases of system tragedy which may cause the loss of the entire system it will recover the loss of the system (Gupta, 2008). ZETDC considers the possible data losses and made use of the external hard drives as well as online drives such as Google drive to secure their source code. The system database also requires backup which was done on a weekly basis. The geographical information system for ZETDC was backed up in such a way that the secured data should be readily available and therefore retrieved quickly. However, system backup was a duty to be performed only by the administrator.

5.6 Recommendations and future work

• For smooth operation of the system, they were recommendations which were identified to be beneficial and they include the following.

- For the smooth functioning of the geographical information system for ZETDC the organization should consider training of both the users of the system as this will help them to use the system as required thereby making the system user-friendly and developers as well to make possible upgrades and amendments of the system.
- The system should also be designed in such a way that all the possible upgrades to be done will not affect user operations.
- In addition the system should provide a manual guide facility for its users thus aiding them on the general uses of the system.
- The system developers should regularly maintain the system to allow the smooth functioning of the system.

5.7 Objective Evaluation

The objective evaluation is of paramount importance since it allows the research team to compare the developed system to the proposed system objectives through the process of calibration and validation of the developed system. Therefore, it has been an incredible delight since all the objectives have been met as expected thus the first objective was to report transformer faults and stores records for future references. Furthermore, the other objective is to gives geographical co-odinates of the transformer thus locating the transformer on the map view. In addition, the system also record time taken to attend to faults helping in coming up with over payments. To be more precisely, the system also provides a chat platform for customers to report faults.




Fig 5.4 Map view of the GIS system




Fig 5.6 Chat forum for the clients and employees






FIG A4: ADD TRANSFORMER


